1. CHAIRMAN'S STATEMENT



We at WINTA are pleased with the continued advances we see in Indigenous tourism through our international network. We hear about Indigenous groups around the globe who are making steady progress in learning about and developing community and nature-based tourism on their own terms. WINTA will provide technical support and guidance as needed to the members of the network. We continue efforts to push back the walls of Indigenous rights denial and social injustice.

The World Indigenous Tourism Summit 2018 held in Aotearoa was a great success with participation from numerous Indigenous South Sea Islanders and other Indigenous groups from that region of the planet.

Representatives from Indigenous groups in the Republic of China (Taiwan) and the Indigenous Ainu from Japan were actively present. We received outstanding leadership from New Zealand Maori Tourism in organizing and presenting the Summit. The Research Symposium held after the Summit was facilitated by Professor Linda Smith from the University of Waikato.

WINTA has continued to build our internal capacity with volunteer agents in Europe and South America. Aurélie Debusschère in France and Jean-Philippe Le Moigne in Chile are highly competent, experienced and dedicated to supporting Indigenous tourism development. Corey Anderson, Content Strategist provides a top-notch web presence for WINTA. Other volunteer positions, including interns, are being added by the Executive Director to bolster WINTA's capacity to better serve Indigenous communities with technical support, advocacy and communications.

We commend the work of the members of WINTA's Leadership Council. John Barrett, Yankila Sherpa, Lennart Pittja, Keith Henry, Frank Antoine and Neville Poelina demonstrate the best kind of leadership in their respective fields of Indigenous tourism. Lennart Pittja received Sweden's prestigious Ecotourism Award of the Year for his Sapmi Nature Camp. He will be speaking at the Adventure Travel Summit in Sweden later this year.

WINTA continues to advocate for the development and advancement of Indigenous tourism as a way to improve human rights and to invest in the future well-being of Indigenous communities, cultures and lands worldwide.

2. MANAGING DIRECTOR'S STATEMENT



From a management perspective, the first 5 years of its operation as a separate legal entity has required WINTA to further expand as a volunteer-based organisation.

WINTA's efforts to raise funds from foundations to meet third-party costs has yet to produce results and WINTA has necessarily expanded its fundraising initiatives to include joint-funding partnership applications in collaboration with country-based organisations for in-country projects.

The minor number of financial transactions undertaken in 2018/19 significantly understates the collaborative project work undertaken by WINTA's volunteer personnel in the practical implementation of the Larrakia Declaration.

A feature of WINTA's facilitation activities in 2018/19 has been the productivity of partnerships with in-country-based organisations as compared with international tourism industry organisations. WINTA activities in Latin America and especially Chile have been particularly noteworthy.

The expansion of WINTA's Global Network into some 69 countries and the range of WINTA's presentation to international Indigenous tourism conferences/events in Australia, Chile, Germany, New Zealand, Peru, Switzerland and USA added considerably to WINTA's networking activities.

The delivery of the World Indigenous Summit 2018 by NZ Maori Tourism and the subsequent advancement of planning by WINTA with WITS 2020 and WITS 2022 auger well for the future.

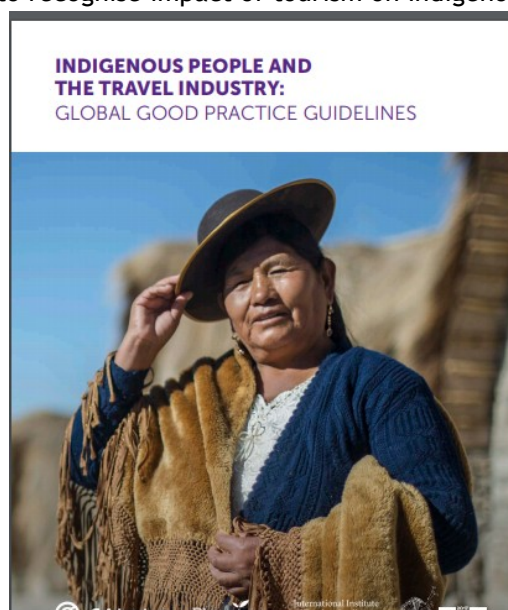
Advocacy Outcomes and Outputs

In implementing its Advocacy objectives WINTA has further reinforced its role as the global umbrella organization for tourism-related Indigenous issues and opportunities WINTA and has:

- Maintained a Leader Council with mixed gender representation
- Expanded Leadership Council meetings to include secretariat personnel
- Successfully transitioned volunteer personnel responsible for the role of online content strategist
- Maintained a volunteer in the role of Europe Agent
- Deployed additional volunteers for philanthropy development coordinator and for Latin America Agent roles
- Commenced the process for recruitment of University graduates seeking internships
- Expanded WINTA's database of Indigenous tourism organisations & leaders, Indigenous researchers and government officials
- Completed due diligence reports for Argentina, Peru & British Guyana
- Made significant progress developing WINTA's *Indigenous Tourism Engagement Framework*, to assist industry stakeholders' engagement with Indigenous communities
- Commenced collaboration with University of Lapland & other parties in the delivery of the Arctisen Research Project *Culturally Sensitive Tourism in the Arctic*



- Promoted the Larrakia Declaration - for use by Indigenous tourism operators; in inter-nation Indigenous Tourism Research Projects; during stakeholder meetings in Chile, Peru & Argentina; in guest university lectures; in Indigenous tourism leaders forums; at international conferences; in EMRIP side event in Geneva & during the Arctisen research project.
- Continued to advocate implementation of the 2030 SDGs to recognise impact of tourism on Indigenous Peoples;
- Promoted *Indigenous People & the Travel Industry: Global Guidelines to Good Practice*
- Distributed a significant number of case studies of Indigenous and tourism engagement to WINTA's Global Network



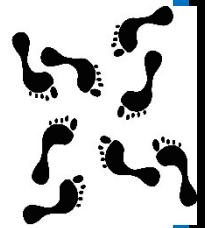
Facilitation Outcomes and Outputs

In facilitating relationships between Indigenous and non-Indigenous peoples, WINTA has provided Indigenous peoples with their own collective voice and ability to engage with global tourism industry organisations based on mutual respect and has:

- Partnered with Fundación Travolution and advised government on the *Design of a Roadmap for the development of Indigenous tourism in Chile*
- Partnered with Travolution.org, the Global Community-based Tourism Network SpA, to provide travellers on selected Travolution tours with the opportunity to contribute funds for deployment by WINTA in support of Indigenous tourism development in South America
- Entered into a MOU with Fundación CODESPA to collaborate in community-based tourism projects sought by Indigenous communities seeking empowerment through tourism
- Supported the Guyana Tourism Authority in their design of a Community-Owned & Led Tourism Framework
- Entered into an MOU with the Ma'u Henua Community in Rapanui.

THE FEATURE INTERNATIONAL INDIGENOUS TOURISM EVENT IN 2018

Thanks to the enormous effort that NZ Māori Tourism put into hosting the WITS 2018 in April 2018, WINTA considered that WITS 2018 was the feature international Indigenous Tourism Event in 2018.



Dale Stephens, Chairperson, NZ Māori Tourism had some post Summit observations to share about the event.

“NZ Māori Tourism welcomed many of our Indigenous whanau (family) at the World Indigenous Tourism Summit we co-hosted with World Indigenous Tourism Alliance (WINTA) in the Bay of Islands in April 2018”.

Norbu Tenzing and Heather Rae were our keynote speakers, and their presentations provoked discussions that are still reverberating today”.

More than a year following the Summit and accompanying Research Symposium, we continue to receive messages on the Summit and how it has fostered new thinking, strengthened relationships, forged the way for new partnerships and ideas to come to fruition, and has set a high mark for future tourism conferences not only in New Zealand, but worldwide. We made a concerted effort to not only showcase New Zealand, but to focus on the Taitokerau region and Māori through every aspect of the event - from the food, transport, entertainment, audio visuals, famils, design - Māori were involved intimately in every part of the Summit and Research Symposium.



NZ Māori Tourism were conscious that we didn't want this to be a typical conference. By having the majority of delegates stay on site to enable relationships to form in and around the set conference programme, and providing unique conference experiences (including an outdoor film evening complete with beanbags and blankets!), and the opportunity to engage in local Māori tourism, we know we succeeded in our goal.

A huge thank you to the many Māori and international indigenous tourism experiences that attended and supported the Summit and Research Symposium - we look forward to seeing you in Perth in 2020!

5. REGULATORY FRAMEWORK

The regulatory framework for the corporate governance and management of WINTA is provided by both the WINTA Constitution and NZ legislation.

The WINTA Constitution was adopted on 30 May 2014 by special resolution of shareholders, pursuant to section 32 Companies Act 1993. The Constitution shares responsibility for the corporate governance and management of WINTA between the Leadership Council and the Director.



6. GOVERNANCE

Leadership Council

- Role

Schedule 1 of the Constitution places responsibility on the Leadership Council to set the strategic direction of WINTA and approve the annual plan/budget and adopt policies to guide the operation of WINTA.

- Operating Policy

The operating policy adopted by the Leadership Council in 2014/15 remained in force in 2018/19.

- Composition/Appointees

Clause 1.1.1.a of the Constitution provides that each shareholder may appoint one person to the Leadership Council and may subsequently remove that person and appoint another person to the Leadership Council.

The shareholder appointees for 2018/19 were:

- Mr John **Barrett** appointed by the NZ Maori Tourism Society;
- Ms Brenda **Baptiste** retired and Mr Frank **Antoine** was subsequently appointed by the Indigenous Tourism Association British Columbia.
- Mr Lennart **Pittja** appointed by Vägvisaren-samiska upplevelser;
- Mr Neville **Poelina** appointed by the WAITOC Association Inc;
- Mr Ben **Sherman**, appointed by the Native Tourism Alliance;
- Ms Yankila **Sherpa** appointed by the Trans Himalayan Environment Livelihood Program;
- Mr Keith **Henry**, Chairman/CEO Aboriginal Tourism Association of Canada co-opted by the appointed Leadership Councillors.

- Selection/Role of Chairman

Leadership Council corporate policy 1.2.3 provides that the shareholder appointees shall elect one of the shareholder appointees as Council Chairperson and once elected, that person shall hold that office until he or she dies or resigns or is no longer a shareholder appointee or the majority of shareholder appointees elect a chairperson in his or her place.

The shareholder appointees elected Mr Ben Sherman to chairman of the Leadership Council on 7 August 2014 and his tenure as Chairman remained unchanged during 2018/19.

- Diversity

All councillors have a background in Indigenous tourism and bring first-hand experiences from Asia, Australia, Europe, North America and Oceania. At present the only continents still not participating on the Council are Africa and South America.

The gender balance changed during 2018/19 and comprised of 1 woman and 6 men at year end.

- Council Meetings

All Leadership Council meetings were conducted via skype and were held on:

- 25 May 2018
- 22 June 2018
- 24 August 2018
- 23 November 2018
- 22 February 2019
- 23 March 2019

These meetings proceeded as Council discussion sessions and no specific issues required decision by a quorum.

The Director prepared and distributed the agendas in advance of all Council meetings. The Director also prepared/distributed meeting notes following the Council discussion sessions.

- **Council Performance**

As required by the constitution, the Leadership Council approved WINTA's 2018/19 annual plan/statement of intent. Council also retained its established Strategy Statements (positioning, vision, mission, corporate values, objectives) and its established operating policies without change.

- **Council Remuneration**

Chairman Ben Sherman was reimbursed for travel expenses associated with attending the ITB 2019 in Berlin (March 2019).

- **Interest in transactions**

Council policy requires that all councillors comply with the intent of Clause 21 of the WINTA constitution and Section 139-144 Companies Act 1993 which prescribe the restrictions that apply to self-interest transactions. All meeting agendas enabled councillors to disclose an interest in any agenda item/transaction and the recording of those interests in a WINTA *interests register*.

No self-interests in transactions were declared by Councillors or recorded in the interests' register.

Committees

No Council committees were formed by the Leadership Council.

7. SECRETARIAT

Managing Director

- Role

Schedule 1 of the WINTA constitution requires the Director to manage, direct and supervise the management of the business and affairs of the company, in accordance with the strategic plan, the annual plan and budget, and the operating policies for the company as approved by the Leadership Council. In addition, the Director is obligated to meet minimum compliance requirements set out in the Companies Act 1993. These obligations include acting in good faith and in best interests of the company, avoiding reckless trading and entering into obligations that cannot be met. Any breach of these obligations constitutes an offence under the Companies Act 1993.

- Remuneration

No remuneration was paid to the Managing Director.

The role of Managing Director was undertaken by Mr Johnny Edmonds who also met all costs incurred in fulfilling the role of Director.

8. ANNUAL SHAREHOLDERS' MEETING & AUDITORS

Dividend Policy

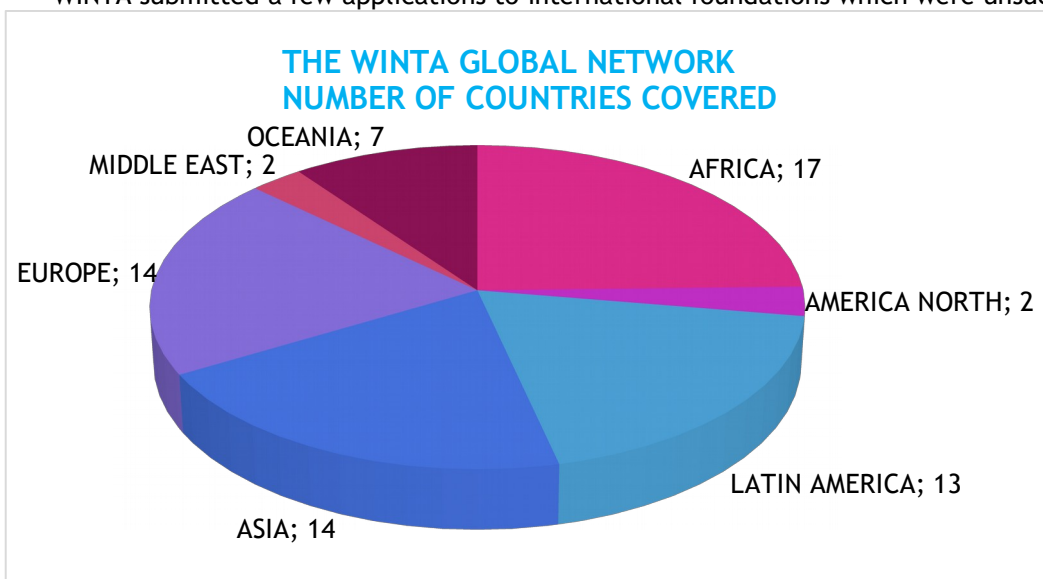
Part 2 Special Provisions of the WINTA constitution provides that the Company shares shall not confer on shareholders entitlement to payment of dividends, or preferential rights to distributions of capital or income, or rights to transmit or transfer shares to other than the company, or pre-emptive rights to new shares.

Furthermore, Company shares may only be transferred to corporate entities that subscribe to the charitable purpose of the company.

10. OPERATING TRENDS

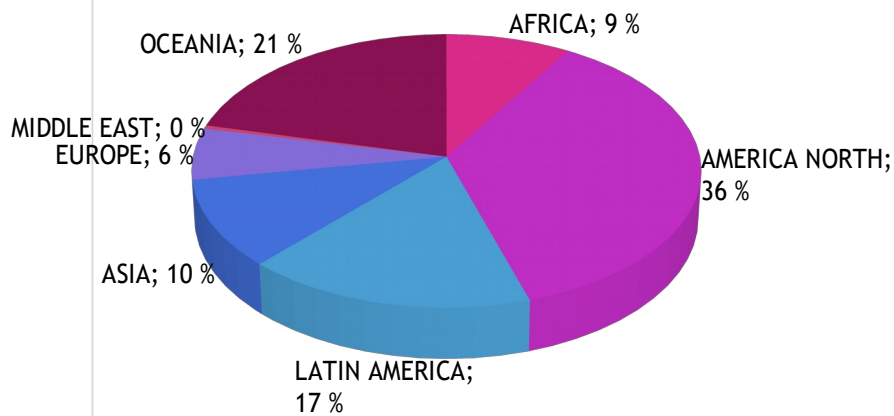
10.1 ADVOCACY Related Trends

- A minor number of financial transactions were undertaken in 2018/19 significantly understates the collaborative project work undertaken by WINTA's volunteer personnel.
- The WINTA constitutional provisions for WINTA Shareholdings and Leadership Council membership proved adequate for 2018/19 but consideration still needs to be given to involving Indigenous Leadership from the African and South American continents and increasing women participation.
- The number of scheduled skype meetings of the Leadership Council exceeded the minimum requirements under the constitution; however, all meetings were conducted as discussions opportunities by the few participating Councillors during each meeting.
- The core workforce of volunteers was further expanded with the establishment & appointment to the new volunteer positions of WINTA Latin America Agent and philanthropy development coordinator;
- The Larrakia Declaration remained central to WINTA's advocacy activities but requires more emphasis on its practical implementation by Indigenous tourism industry stakeholders.
- A principal issue that has continued to elude WINTA was securing funds to meet third-party costs. WINTA submitted a few applications to international foundations which were unsuccessful

Most Network participants reside in North America, Oceania, Latin America and Asia

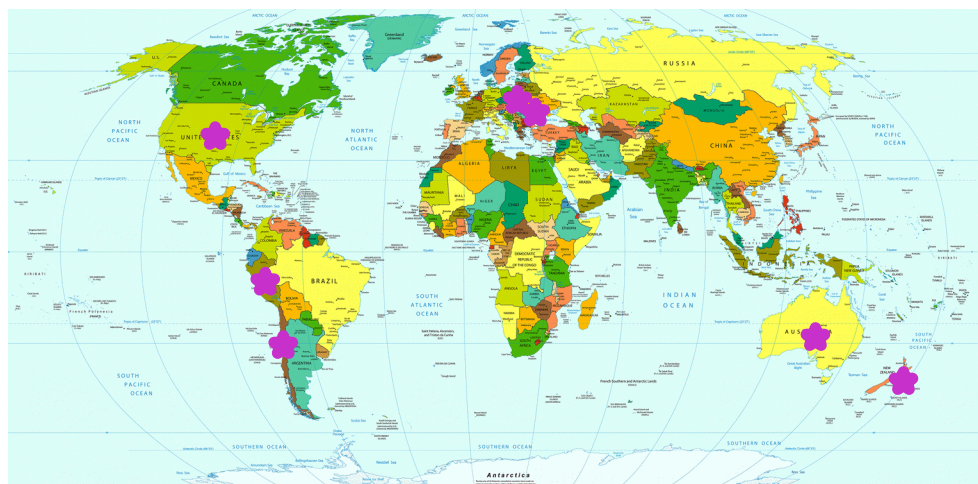
10.2 FACILITATION Related Trends

- A feature of WINTA's facilitation activities in 2018/19 has been the productivity of partnerships with in-country-based organisations as compared with international tourism industry organisations;
- WINTA continued its focus on the delivery of projects in South America through partnership arrangements with Travolution and with government;
- WINTA retained its partnership MOUs with international tourism industry associations, ATTA, ITAC, PATA and TEFI but little collaborative initiatives eventuated during 2018/19;
- One new MOU was entered into with the international Fundación CODESPA to collaborate in community-based tourism projects sought by Indigenous communities seeking empowerment through tourism
- WINTA continued with joint-funding partnership applications in development with country-based organisations in Finland, Nepal and Papua New Guinea;
- WINTA facilitated other requests it received from government and industry organisations for assistance related to their engagement with Indigenous tourism.

10.3 NETWORKING Related Trends

- Expanded the Global WINTA Network of stakeholders to some 69 countries;
- Maintained the distribution of online E-news to an average of 2 per month;
- Continued Facebook as WINTA's principal social media networking
- Commenced active participation in UN Indigenous people's forums in New York & Geneva

- Contributed to a range of international Indigenous tourism-related conferences/events in Australia, Chile, Germany, New Zealand, Peru, Switzerland and USA.
- Co-championed Indigenous tourism leaders' meetings in Chile
- Completed intensive in-country consultation with government & Indigenous tourism stakeholders Chile, Peru & Argentina
- Collaborated with NZMT in the delivery of the World Indigenous Summit 2018
- Advanced planning with WITS 2020 and WITS 2022

12. ECONOMIC PERFORMANCE

12.1 Overview

A minor number of financial transactions were undertaken by WINTA in delivering the annual plan as most outputs were provided through volunteer and partnership support during 2018/19.

WINTA did manage to generate limited revenue through the provision of consultancy service to Fundacion Travolution for development projects in support of Indigenous tourism in Chile.

However, the estimated value of the pro bono services, & partnership support provided to WINTA's operational activities again exceeded NZ \$300,000.

The single activity having the greatest value impact was the World Indigenous Tourism Summit 2018 delivered and sponsored by partner NZ Maori Tourism Society.
